- 2. Uploaded proof of non-refundable processing fee payment (RM25/local, USD25/international)

- 4. Uploaded copy of degree certificate
- 5. Uploaded of project proposal (for research structure only)
- 6. Uploaded report of an academic referee or recommendation letter
- 7. Uploaded Financial Statement / Bank Statement / Bank Guarantee / Sponsorship Letter
- 8. Uploaded Evidence of English Proficiency (as required)
