<b>6</b>	<p><b>Analisis dan Tafsiran (<i>Analysis and interpretation</i>)</b>  <i>The original contribution of the candidates should be evident in the chapters devoted to analysis and conclusions drawn from the research work. Credit should be given to a candidate who shows intelligent application of appropriate principles and practices relevant to the problem under study. Credit should also be given to candidate's ability to analyse critically the data collected and to his ability to write a coherent and descriptive dissertation from the data and materials collected.</i></p>

Style is also relevant as well as accuracy and care especially proof reading of the final copies.</i></p>
